WHAT IS A VISA?

A VISA IS AN AUTHORISATION IN THE FORM OF A STICKER THAT IS AFFIXED TO YOUR PASSPORT WHICH AUTHORIZES THE BEARER TO STAY OR TRAVEL IN THE COUNTRY YOU ARE APPLYING FOR.

THE POSSESSION OF A VISA DOES NOT HOWEVER GIVE A THIRD-COUNTRY NATIONAL THE AUTOMATIC RIGHT OF ENTRY INTO THE COUNTRY AS YOU WILL HAVE TO MEET OTHER CONDITIONS SUCH AS FINANCIAL SUBSISTENCE AND DETAILS OF STAY.

MALTA MAINLY ISSUES TWO TYPES OF VISA:

SCHENGEN VISA- SHORT STAY - FOR STAYS NOT EXCEEDING 90 DAYS

THE NATIONAL VISA- LONG STAY- OVER 90 DAYS BUT NOT EXCEEDING 1 YEAR

WHAT IS A VISA?

.....

WHEN YOU APPLY FOR YOUR VISA IT WILL NEED TO BE BASED ON YOUR INTENDED MOVE, SUCH AS STUDY, WORK, OR TRAVEL.

THEREFORE, YOUR FIRST DECISION TO MAKE IS WHAT IS YOUR INTENTION OF TRAVEL?

IF YOU APPLY FOR STUDY YOU WILL APPLY FOR A VISA BASED ON THE DURATION OF THE COURSE SO YOU WILL NEED TO KEEP THAT IN MIND.

APPLYING FOR A VISA BASED ON EMPLOYMENT, MEANS THAT YOUR EMPLOYER OR THE RECRUITMENT COMPANY WILL HAVE APPLIED FOR THE WORK PERMIT FOR YOU WHICH ONCE ACCEPTED IS VALID FOR ONE YEAR WITH THE OPTION TO RENEW EVERY YEAR.

THESE STEPS MUST BE DONE BEFORE APPLYING FOR THE VISA.

THINGS TO LOOK OUT FOR:

THERE ARE SEVERAL SIGNS TO WATCH OUT FOR WHEN IT COMES TO SCAMMERS ON THE INTERNET FOR WORK PERMITS, TO AVOID:

1. UNSOLICITED EMAILS: IF YOU RECEIVE AN EMAIL FROM SOMEONE YOU DON'T KNOW, OFFERING YOU A WORK PERMIT, BE WARY.
2. REQUESTS FOR MONEY: IF SOMEONE ASKS YOU FOR MONEY IN EXCHANGE FOR A WORK PERMIT, WITHOUT ANY PROOF OF A JOB OR LEGITIMATE RECRUITMENT COMPANY WITH NO CONTACT WITH THEM IN REGARDS TO THE PROCESS, BEWARE.
3. LACK OF PROFESSIONALISM: IF THE PERSON CONTACTING YOU ABOUT A WORK PERMIT USES POOR GRAMMAR AND SPELLING, OR THEIR EMAIL LOOKS UNPROFESSIONAL, IT MAY BE A SCAM.

THINGS TO LOOK OUT FOR:

4. PRESSURE TO ACT QUICKLY: IF THE PERSON OFFERING YOU A WORK PERMIT IS PRESSURING YOU TO ACT QUICKLY, IT'S LIKELY A SCAM. LEGITIMATE APPLICATIONS TAKE TIME TO PROCESS, AND THERE'S NO REASON TO RUSH.

5. UNUSUALLY HIGH SUCCESS RATE: IF THE PERSON PROMISING TO GET YOU A WORK PERMIT GUARANTEES A HIGH SUCCESS RATE, IT MIGHT BE A SCAM. REALISTIC EXPECTATIONS WON'T BE PERFECT, BUT NO ONE IS 100% CERTAIN, AND THE RATES CAN NEVER BE PREDICTED TO THAT EXTENT.

MAKE SURE YOU ARE CONFIDENT YOU ARE DEALING WITH THE RELEVANT COMPANIES THAT SUPPORT AND FACILITATE THE WORK PERMITS AND VISAS, THEY ARE LISTED IN THIS EBOOK TO HELP YOU AVOID GOING THROUGH AN ILLEGITIMATE COMPANY.

VISA OPTIONS:

AFTER YOU HAVE DECIDED ON YOUR INTENTION FOR COMING TO EUROPE, MALTA, YOU WILL THEN HAVE TO GO DOWN ONE OF THE ROUTES TO SECURING YOUR STAY IN MALTA BEFORE YOU THEN APPLY FOR THE VISA.

THE 3 DIFFERENT OPTIONS FOR YOU FOR MOVING TO MALTA AND THEN SECURING YOUR VISA ARE:

-STUDY

-WORK

-TRAVEL

STUDENT VISA

TO GET A STUDENT VISA, YOU FIRST NEED TO APPLY TO A UNIVERSITY OR SCHOOL IN MALTA AND RECEIVE AN ACCEPTANCE LETTER.

YOU WILL NEED TO PROVIDE VARIOUS DOCUMENTS, SO IT'S IMPORTANT TO START THE PROCESS WELL IN ADVANCE OF YOUR INTENDED START DATE TO ALLOW FOR ANY UNFORESEEN DELAYS OR COMPLICATIONS.

THERE ARE TWO TYPES OF STUDENT VISAS YOU CAN APPLY FOR:

-SHORT STAY SCHENGEN STUDENT VISA (FOR COURSES LESS THAN 90 DAYS) THIS CANNOT BE EXTENDED.

-LONG STAY STUDENT VISA- FOR COURSES OVER 90 DAYS

STUDENT VISA

FOR THE SHORT-STAY SCHENGEN VISA, YOU WILL ONLY BE ABLE TO STAY IN MALTA, FOR THE DURATION OF YOUR COURSE WHICH DOES NOT EXCEED 90 DAYS. THIS CANNOT BE EXTENDED AND YOU CANNOT WORK OR STAY IN MALTA FOR LONGER THAN THIS PERIOD.

FOR THIRD-COUNTRY NATIONALS APPLYING FOR A VISA FOR STUDY PURPOSES, IT'S MUCH LESS LIKELY TO BE ACCEPTED IF THE COURSE IS LESS THAN 90 DAYS.

IF APPLYING FOR A COURSE THAT IS LONGER THAN 90 DAYS WITH A HIGHER EDUCATION INSTITUTION WHICH LEADS TO A NATIONAL QUALIFICATION YOU WILL APPLY FOR A TEMPORARY RESIDENCE PERMIT ON THE BASIS OF YOUR STUDIES.

SCHOOLS IN MALTA

THIS LIST IS NOT EXHAUSTIVE AND THERE ARE OTHER SCHOOLS IN MALTA YOU CAN CHOOSE FROM, YOU WILL NEED TO MAKE SURE THAT THE SCHOOL AND COURSE ARE LICENCED BY THE NATIONAL REGULATO. YOU CAN FIND THAT INFORMATION ON THE ABOVE LINK.

ONCE YOU HAVE DECIDED ON THE SCHOOL AND COURSE YOU ARE INTERESTED IN, YOU CAN THEN CONTACT THE SCHOOL TO ENQUIRE ABOUT THE COURSE COSTS AND LENGTH ETC.

IDEALLY CHOOSING A COURSE THAT LASTS LONGER THAN 90 DAYS IN DURATION AS A COURSE LESS THAN 90 DAYS, IS LESS LIKELY TO HAVE THE VISA ACCEPTED.

STUDENT VISA PROCESS

TO BOOK THE COURSE, YOU WILL NEED TO PROVIDE YOUR DETAILS AND PAY A DEPOSIT OR AMOUNT FOR THE COURSE IN ADVANCE TO THE SCHOOL AND RECEIVE THE ACCEPTANCE LETTER FROM THEM THAT YOU WILL NEED TO APPLY FOR THE VISA.

FOR COURSES OF VALUE UP TO 1000 EUROS YOU WILL HAVE TO PAY THE AMOUNT IN FULL. FOR COURSES MORE THAN 1000 EUROS BUT LESS THAN 2500 EUROS YOU WILL HAVE TO PAY 75% OF THE COURSE FEE AND FOR COURSES OVER 2500 EUROS YOU WILL HAVE TO PAY 50% OF THE COURSE FEE.

CHECK WITH THE SCHOOL BEFORE BOOKING, HOW MUCH OF THAT AMOUNT IS NON-REFUNDABLE, IF FOR ANY REASON THE VISA IS NOT ACCEPTED. (THEY USUALLY ONLY KEEP AN AMOUNT FOR ADMIN ETC BUT IT IS IMPORTANT YOU ASK SO YOU KNOW BEFORE BOOKING AND PAYING).

PROCESS FOR STUDENT VISA

ONCE YOU HAVE YOUR ACCEPTANCE LETTER FROM THE SCHOOL YOU WILL THEN BE ABLE TO APPLY FOR THE VISA WITH VFS. ENSURE YOU HAVE ALL OF YOUR DOCUMENTS PREPARED AND HAVE FILLED THE VISA APPLICATION FORM IN AND THEN YOU CAN BOOK YOUR APPOINTMENT WITH VFS FOR YOUR VISA.

DEPENDING ON THE DEMAND FOR APPOINTMENTS WILL DETERMINE HOW LONG IT WILL BE FOR THE NEXT AVAILABLE ONE. HERE IS THE LIST OF DOCUMENTS YOU NEED TO PREPARE FOR YOUR APPOINTMENT FOR THE STUDENT VISA:

- APPLICATION FORM FILLED OUT
- PASSPORT - ISSUED WITHIN LAST 10 YEARS, VALID FOR AT LEAST 3 MONTHS FROM THE END DATE OF YOUR STUDIES, HAS AT LEAST 3 BLANK PAGES
- CONFIRMED TRAVEL ITINERARY

DOCUMENTS FOR STUDENT VISA

-TRAVEL INSURANCE WITH 30,000 EUROS COVERAGE - PURCHASED THROUGH ONE OF THE 16 COMPANIES ON THE LINKED LIST.

MICROSOFT WORD - SCHENGEN LIST OF TRAVEL INSURANCE COMPANIES-01-02-2018.DOC (VFSGLOBAL.COM)

-PROOF OF SUFFICIENT FEES TO COVER YOUR STAY (48 EUROS PER DAY FOR DURATION) INCLUDING LIVING COSTS AND TUITION FEES ETC -THROUGH BANK STATEMENTS SIGNED BY BANK

-PROOF OF ACCOMODATION FOR DURATION OF COURSE THAT CAN BE ANY OF THE BELOW:

- CAN BE CONFIRMED HOTEL BOOKING

-CONFIRMATION OF DORMITORY BOOKING

-A RENTAL AGREEMENT SIGNED BY BOTH YOU AND LANDLORD

-A "DECLARATION OF PROOF" FORM COMPLETED IN FULL BY THE HOST WITH A PHOTOCOPY OF THE HOSTS PASSPORT - WITNESSED BY A MALTESE LEGAL PROFESSIONAL

DOCUMENTS FOR STUDENT VISA

- PROOF OF PAYMENT FOR THE COURSE (SEE PAGE 24- FOR PERCENTAGE TO BE PAID UP FRONT)**
- ORIGINAL EDUCATIONAL CERTIFICATES APPLICABLE FOR COURSE - APOSTILLED BY ISSUING COUNTRY**
- ORIGINAL LETTER OF ACCEPTANCE FROM SCHOOL INCLUDING THE START DATE, END DATE, FEES ETC WITH A COPY OF THE TIMETABLE AND SCHEDULE OF COURSE**
- LAST PREVIOUS PASSPORT**
- ADHAAR CARD**

ALL THE ABOVE WILL BE REQUIRED AS ORIGINALS AND PHOTOCOPIES AND YOU WILL PAY YOUR FEE OF 100 EUROS FOR THE VISA PLUS VFS FEES WHICH YOU WILL NEED TO ENQUIRE ABOUT WITH THEM DIRECTLY.

PROCESS FOR STUDENT VISA

ONCE YOU HAVE HAD YOUR VISA APPOINTMENT - DECISIONS ARE USUALLY GIVEN WITHIN 10-15 DAYS OF THE APPOINTMENT.

IF YOU WOULD LIKE SUPPORT WITH THE VISA APPLICATION PROCESS AS A STUDENT YOU CAN CONTACT THE SCHOOL DIRECTLY AND THEY WILL BE ABLE TO ASSIST YOU DIRECTLY. THE UNIVERSITY FOR EXAMPLE HAS A DEDICATED WHATSAPP TEAM FOR INTERNATIONAL STUDENTS AND WILL BE ABLE TO ADVISE YOU.

YOU ALSO HAVE THE OPTION TO USE AN AGENT FOR WHO YOU WILL PAY A FEE TO SUPPORT WITH THE PROCESS FOR YOU, IN TERMS OF APPLICATION, PROCESS, AND APPOINTMENT. IF YOU CONTACT THE SCHOOL YOU HAVE APPLIED TO DIRECTLY, THEY WILL BE ABLE TO GIVE YOU THE DIRECT CONTACT OF THEIR AUTHORISED AGENT IN INDIA SO YOU CAN ENQUIRE ABOUT WHAT IS INVOLVED AND THE FEES.

TEMPORARY RESIDENCE PERMIT

ONCE YOU HAVE ARRIVED IN MALTA, WITH YOUR LONG-STAY VISA, YOU WILL NEED TO APPLY FOR A TEMPORARY RESIDENCE PERMIT WHICH ALLOWS YOU TO STAY IN MALTA FOR THE DURATION OF YOUR COURSE.

TO APPLY ONLINE YOU NEED TO FOLLOW THE BELOW LINK: NON-EU IMA (IDENTITYMALTA.COM)

YOU WILL SELECT REASON "STUDY" AND BE FILLING OUT FORM N . HERE IS THE MANUAL TO SUPPORT WITH COMPLETION OF FORM:

ALONG WITH THE FORM YOU WILL HAVE TO MAKE
A PAYMENT OF 27.50 EUROS AND YOU WILL NEED
TO SUBMIT THE FOLLOWING DOCUMENTS:

- COPY OF FORM ID 1A - IDENTITY REGISTRATION FORM
- ORIGINAL COPY OF PASSPORT
- ORIGINAL SCANNED COPY OF THE OFFICIAL ACCEPTANCE AND/OR ENDORSEMENT LETTER WITH START AND END DATES OF THE COURSE FROM THE SCHOOL
- PROOF OF FINANCIAL MEANS OF SUBSISTENCE
- ORIGINAL COPY OF COMPREHENSIVE HEALTH INSURANCE (COVERING YOU UPTO 30,000 EUROS)
- ACCOMMODATION DOCUMENTS
ORIGINAL CONTRACT WITH ORIGINAL SIGNATURES OF BOTH LANDLORD AND TENANT.

TEMPORARY RESIDENCE PERMIT

IF THE COURSE OF STUDY LEADS TO A HIGHER EDUCATION QUALIFICATION YOU ALSO NEED TO HAVE THE FOLLOWING (AS APPLICABLE):

- PARENTAL DECLARATION (IF APPLICABLE)**
- PROOF OF COVERAGE FOR SICKNESS (IF APPLICABLE)**
- PROOF OF ACCEPTANCE BY THE EDUCATIONAL ESTABLISHMENT (IF APPLICABLE)**

-KEY EMPLOYMENT INITIATIVE:

THIS IS USUALLY ISSUED FOR PEOPLE IN MANAGERIAL POSITIONS OR PEOPLE THAT ARE HIGHLY TECHNICALLY QUALIFIED AND CAN SHORTEN THE PROCESSING TIME TO 5 DAYS.

-EU BLUE CARD:

HOW LONG DOES IT TAKE

THE PROCESS TIME FOR EACH APPLICATION WILL VARY DEPENDING ON YOUR REASON FOR TRAVEL, THE VISA BEING APPLIED FOR, THE CURRENT WORKLOAD OF AUTHORITIES, AND YOUR CIRCUMSTANCES.

AS YOU NEED TO GO THROUGH VFS GLOBAL NO MATTER WHICH VISA YOU APPLY FOR, YOU WILL NEED TO BOOK AN APPOINTMENT WITH THEM WHICH SHOULD BE WITHIN 8 WEEKS OF APPLYING.

IF APPLYING FOR A VISA DUE TO WORK, YOU WILL NEED TO APPLY FOR THE WORK PERMIT FIRST WHICH CAN TAKE UP TO 6 MONTHS DEPENDING ON THE DEMAND AND THE WORK PERMIT BEING APPLIED FOR. IT COULD BE SOONER, BUT YOU NEED TO TAKE INTO ACCOUNT THESE TIME FRAMES.

FOR A STUDENT VISA - THE SCHENGEN VISA DECISION SHOULD BE BETWEEN 15-30 DAYS FROM APPLICATION UNTIL YOU GET THE ANSWER.

STUDENT VISA:

ONCE YOU HAVE APPLIED AND BEEN ACCEPTED AT THE SCHOOL YOU HAVE APPLIED FOR YOU CAN THEN APPLY FOR THE STUDENT VISA- THIS SHOULD BE PROCESSED WITHIN 15-30 DAYS BUT CAN BE LONGER DUE TO DEMAND.

VISA FOR WORK:

FIRST OF ALL, YOU WILL BE APPLYING FOR THE WORK PERMIT:

SINGLE WORK PERMIT - 2-3 MONTHS BUT CAN BE UP TO 6 MONTHS

KEY EMPLOYMENT INITIATIVE - 5 DAYS

EU BLUE CARD - SHOULD BE WITHIN 90 DAYS

ONCE YOU THEN HAVE YOUR WORK PERMIT AND HAVE YOUR APPOINTMENT FOR A VISA IT SHOULD BE PROCESSED WITHIN 10-15 DAYS DEPENDING ON WORKLOAD AND APPLICATION NUMBERS.

TOURIST VISA:

THE SCHENGEN VISA DECISION WILL BE BETWEEN 15-30 DAYS FROM THE APPLICATION UNTIL YOU GET THE ANSWER.

ALL OF THESE TIME FRAMES ARE ESTIMATES AND CAN BE HUGELY AFFECTED BY THE WORKLOAD OF VFS AND MALTA AUTHORITIES SO ALWAYS TAKE THEM INTO ACCOUNT WHEN PLANNING YOUR DATES FOR YOUR TRAVEL OR MOVE TO MALTA.

YOU WILL NEED TO MAKE SURE YOU PLAN AHEAD OF YOUR TRIP SO YOU DO NOT LOSE TIME OR MONEY FOR THE TRIP.

YOU WILL BE ABLE TO SEE WHEN THE NEXT VFS APPOINTMENTS ARE ONLINE BUT THE TIME FRAME FOR WORK PERMITS CAN VARY A LOT AND IDENTITY MALTA WILL NOT BE ABLE TO GIVE YOU A SPECIFIC TIME FRAME.

WHY VISAS GET REJECTED

THERE ARE A FEW COMMON MISTAKES THAT ARE MADE WHEN APPLYING FOR A EUROPEAN VISA THAT CAN LEAD TO REJECTION. HERE ARE SOME OF THEM TO AVOID:

1. LACK OF DOCUMENTATION: FAILING TO PROVIDE ALL THE REQUIRED DOCUMENTS SUCH AS FINANCIAL RECORDS, TRAVEL ITINERARY, EMPLOYMENT LETTER, AND ACCOMMODATION DETAILS.
2. INCOMPLETE APPLICATION: A POORLY FILLED OUT APPLICATION FORM. ENSURE THAT YOU FILL OUT ALL SECTIONS CORRECTLY AND PROVIDE ACCURATE INFORMATION.
3. IT IS ALSO VITAL TO PREPARE ALL NECESSARY DOCUMENTS CAREFULLY, BE HONEST, FOLLOW THE RULES, AND DO NOT FORGET TO STAY POSITIVE.

WHY VISAS GET REJECTED

4. INSUFFICIENT FUNDS: NOT HAVING SUFFICIENT FUNDS TO SUPPORT YOUR TRAVEL AND STAY IN EUROPE IS A COMMON REASON FOR VISA DENIAL. MAKE SURE YOU HAVE ENOUGH MONEY IN YOUR BANK ACCOUNT TO SHOW THAT YOU CAN SUPPORT YOUR TRIP.

5. PREVIOUS VISA REJECTIONS: IF YOU HAVE HAD PREVIOUS VISA REJECTIONS, IT CAN NEGATIVELY IMPACT YOUR CURRENT VISA APPLICATION. IN SUCH CASES, IT IS ESSENTIAL TO PROVIDE A CLEAR EXPLANATION OF WHY YOUR PREVIOUS VISA WAS DENIED.

6. LACK OF TRAVEL HISTORY: HAVING NO TRAVEL HISTORY OR WEAK TRAVEL HISTORY (NOT VISITING ANY COUNTRY ABROAD) CAN ALSO LEAD TO VISA REJECTION. IF THIS IS YOUR SITUATION, CONSIDER TRAVELING TO A FEW OTHER COUNTRIES FIRST BEFORE APPLYING FOR A EUROPEAN VISA.
